

# Psychosis MRI Shared Data Resource (Psy-ShareD) Partnership Data Sharing Memorandum of Understanding

## 1. Partners

This Memorandum of Understanding (MoU) pertains to the Psychosis MRI Shared Data Resource Partnership, hereinafter referred to as the *Psy-ShareD Partnership*. The *Psy-ShareD Partnership* leadership team are listed below. The Overall Psy-ShareD Principal Investigator is Professor Paul Allen.

Additional *Psy-ShareD Partners* are those that contributed MRI and linked clinical and cognitive data in the *Psy-ShareD Partnership*. The current list of *Psy-ShareD Partners* can be found <a href="https://example.com/here">here</a>. Those applying to access and use Psy-ShareD data via a Data Access Request process are referred to as the *Data Users*.

#### 2. Overview

All Psy-ShareD MRI, demographic, clinical, and cognitive data is stored at *King's College London (KCL)* Neuroimaging Network. For datasets originating from external sites, a

Data Sharing Agreement (DSA) must be established prior to any data transfer. A DSA must be approved by KCL and the contributing institution that is transferring data to the *Psy-ShareD Partnership*. Once data (MRI, clinical, cognitive, demographic) is transferred to KCL it can only be accessed by Psy-ShareD team members (employed by KCL) for processing, curation and harmonisation procedures.

Data access requests for Psy-ShareD data will be managed via a web-form available via the Psy-ShareD <u>website</u>. All publications resulting from Psy-ShareD data will list the *Psy-ShareD Partnership* **plus** the site Pls/Co-ls for the datasets used in the publication. *Data Users* and the *Psy-ShareD Partnership* will be named on the author list where the number of co-authors is limited, e.g. meeting abstracts (TBC).

#### 3. General Policies

# Contributing & Sharing data

After a Data Sharing Agreement has been established between KCL and the local site data contributor, the site Pls are responsible for ensuring de-identification of their site's MRI, demographic, clinical, and cognitive data. Data should be de-identified at each site using the tools provided by Psy-ShareD and then sent to the King's College London via a secure data transfer system (BitBox). As staff at King's College London will not have access to the external site key identifiers, which potentially link external site data to personal information, the data will be pseudo anonymised for KCL staff. Once transferred to KCL, external site data will only be identified using a unique Psy-ShareD ID generated prior to data transfer (e.g. PSYD\_0201\_sub001\_b). This ID code denote the site (02) the study number within that site (01), the subject number (sub001), and if the scan is a baseline or follow-up scan (b or f). The Psy-ShareD ID code also links MRI data to associated clinical, cognitive, and demographic data.

Both the site PIs who contribute data to Psy-ShareD *Data Users* are responsible to comply with all relevant rules and regulations imposed by their local institution. *Data Users* are responsible for arranging local IRB or Ethics Committee approvals. Psy-ShareD will facilitate and support (where possible) *Data Users* requiring local approvals.

Data Users are responsible for ethical approvals required by their local institution and required to provide details (i.e., approval numbers/codes) in the Data Access Request

form. *Data Users* are required to complete a Data Use Agreement (DUA) with KCL and are not permitted to share Psy-ShareD data with third parties. The DUA requires that *Data Users* keep a document stating who (i.e., local researchers) has access to these data.

#### 4. Data Access

Here we outline the policy for sharing data from the *Psy-ShareD Partnership* as well as detailed policies for publication and publication credits. The intent of these policies is to facilitate the sharing of data, to encourage academic productivity, and to provide a mechanism for tracking and archiving data requests, intended analyses, and publications related to and resulting from Psy-ShareD data.

The Psy-ShareD Partnership include investigators from contributing sites who are actively engaged in psychosis neuroimaging research and who have contributed anatomical (T1) MRI, demographic, clinical, cognitive/neuropsychological data to Psy-ShareD. Data Users can access these data by submitting a proposal application for data access and data-analysis and publication using the Data Access Request form. The Data Request Access form will be used to monitor and log data access requests, so that potential overlap with other proposals will also be assessed. Once a data access request is received, the Psy-ShareD Partnership will notify Psy-ShareD Partners whose data has been request for access. Partners whose data has been requested must give their approval before their data is transferred to a Data User. For all data access requests, the Psy-ShareD Partnership will also consider the scientific merit, feasibility, originality and/or potential for the education and training of next generation psychosis researchers and may provide feedback to the Data User to strengthen these elements of their access request. The Data Access Request form will also need to provide details about local ethics approvals or confirm that a local ethics ethics application is in progress. Other information is also required in the Data Access Request form that will allow a Data Access Contract to established between King's and the recipient institution (i.e. the Data User's affiliated institution). The Data Access Contract will need to be agreed and signed by King's and the recipient institution.

Normally, the Data Access Request form should include a proposal for publication of a specific scientific paper, not for multiple papers on a more general topic. Analysis plans

should include specific research questions, and hypotheses (see section 6 of the from). To attempt to avoid overlap between studies/papers resulting from different analysis plans, the data analyses and results reported in the manuscript are limited to those described in the analysis plan. For additional analyses not described in the analysis plan a new analysis plan needs to be submitted. The Psy-ShareD Website will be updated on a regular basis with a list of approved projects using this resource to avoid duplication of efforts; and encourage new collaboration between teams.

No site data will be shared without the consent of the *Psy-ShareD Partner* of that site, who may opt to impose specific conditions or limitations on the use of the data; also *Psy-ShareD Partners* are not obliged to take part in any project, although they are strongly encouraged to work with *Data Users* as a co-author and/or a mentor where the *Data User* is a more junior researcher. Submission of a proposal implies actual plans for a publication, which will be worked on within a reasonable time frame specified in the proposal. Once a data access request has been approved by the Psy-ShareD Partnership, The KCL Contracts Office will prepare a data sharing contract with the Data Users and/or Data Users intuition.

# 5. Publication Policy

Psy-ShareD will provide each *Data User* with a set of publication resources including a step-by-step guide for submissions and resources for standardised authorship approval tracking. Specific publication policies are listed below:

## Manuscripts:

1. We request that the manuscript will be submitted to the *Psy-ShareD Partnership* (Psy\_ShareD@kcl.ac.uk) prior to circulating it to all co-authors and prior to submitting to a journal. This review is intended to ensure that provisions described in the analysis plan, as described in the Data Access Request form are correctly implemented and to avoid overlap with other Psy-ShareD projects/manuscripts. *Psy-ShareD Partnership* will maintain confidentiality of the manuscript and will complete its review within 2 weeks.

- 2. People involved in the primary design, analysis and writing parts of the project/manuscript (usually the Data User(s)) will be listed as first and/or senior (last) authors. In addition, the Psy-ShareD Partnership (rather than individual Members) will be listed on the author line, as well as Psy-ShareD Partners who are site Pls/Co-Is for datasets that have been used in each publication. These conditions are mandatory. All citations resulting from Psy-ShareD publications will be linked to all data contributors (Partners) via the Psy-ShareD author listing DOI.
- 3. Funding by the UK Medical Research Council (https://www.ukri.org/councils/mrc/) will be acknowledged in the support acknowledgement section of the manuscript using language like the following:

  The Psy-ShareD Partnership gratefully acknowledges support from the UK Medical Research Council award number MR/X010651/1.
- 4. Confirmed approval of all authors on the article's content and their co-authorship is required before it is submitted to a journal. This will be via a standardised author approval template that is provided to *Data Users* upon data access approval.
- 5. It is the responsibility of the first and/or senior author (usually the *Data Users*) that the guidelines for authorship are followed, that the sample and the researchmethodology are described correctly. It is also required that the *Data Users* maintains documentation of all co-authors' approval of the final manuscript prior to submission and that this authorship approval documentation is accessible by the *Psy-ShareD Partnership*.

Conference posters and oral/symposia abstracts do not require approval from the *Psy-ShareD Partnership*. The following author lines are requested:


#### Conference poster and talk abstracts:

- 1. If the conference allows listing all contributing authors, please include all contributing authors on the author line.
- 2. Author lines should include the Data Users and site Partners and the 'Psy-ShareD Partnership' must also be listed.

- 3. If all authors cannot be listed, consider putting in the abstract "Contributing Authors are listed at psyshared.com.
- 4. Regardless of the names listed on the abstract, it is best to list all Partners/Coauthors on the conference poster and/or the conference acknowledgement slide.

# Symposium submissions:

- 1. List the presenting author, and if possible, on behalf of the *Psy-ShareD Partnership*. Again, if possible consider putting in the abstract "Contributing Authors are listed at psy-shared.com.
- 2. Regardless of the abstract, all contributors should be listed on the symposium talk acknowledgement slide.
